



## NMFS Announces Public Hearings for Draft Amendment 5 to the 2006 Consolidated HMS FMP

December 11, 2012

On November 26, 2012 (77 FR 70552), the National Marine Fisheries Service (NMFS or we) published a proposed rule for draft Amendment 5 to the 2006 Consolidated Highly Migratory Species (HMS) Fishery Management Plan (FMP) in response to several shark stock assessments that were completed from 2009 to 2012. The assessments for Atlantic blacknose, dusky, and scalloped hammerhead sharks indicated that these species are overfished and experiencing overfishing. As described in the proposed rule, we are proposing measures that would reduce fishing mortality and effort in order to rebuild overfished Atlantic shark species while ensuring that a limited sustainable shark fishery can be maintained consistent with our legal obligations and the 2006 Consolidated HMS FMP. The proposed measures include changes to commercial quotas and species groups, the creation of several time/area closures, a change to an existing time/area closure, an increase in the recreational minimum size restrictions, and the establishment of recreational reporting for certain species of sharks. Any comments received during the comment period will be considered in the development and finalization of Amendment 5 to the 2006 Consolidated HMS FMP.

We will hold six public hearings in Florida (2), Massachusetts, Louisiana, New Jersey, and North Carolina, and two conference calls/webinars to provide the opportunity for public comment on the measures described in the proposed rule and draft Amendment 5. Additionally, we will consult with the HMS Advisory Panel on January 8, 2013, on the proposed rule and draft Amendment 5. This HMS Advisory Panel meeting will consist of a presentation of the proposed measures, a discussion with the Advisory Panel, and the opportunity for public comment during an open session. NMFS has also asked to present information on the proposed rule and draft Amendment 5 to the Caribbean, Gulf of Mexico, South Atlantic, Mid-Atlantic, and New England Fishery Management Councils. Information on the date and time of that presentation will be provided on the appropriate council agenda
